STAGE	FOCUS AREA	SAFEGUARDING GAP ADDRESSED
B – BUILD	Medical & cultural norms	Cultural difference being misidentified as neglect
R – RECOGNISE	Cumulative trauma	Harm being missed due to “colour-blind” recording
I – INTERVENE	Partnership & trust	Premature escalation and family disengagement
D – DEFEND	Environment & curriculum	Identity harm impacting wellbeing and behaviour
G – GUARD	Bias & decision-making	Adultification leading to punitive responses
E – EVALUATE	Data & trends	Disproportionality being hidden in systems
